

Environmental Policy

At Alpiq Csepeli Szolgáltató Kft., the Environmental Policy is based on the Company's belief that all incidents which cause environmental contamination, can be prevented, and that none of the activities is worth incurring any danger to the environment. Environmental protection is a key value at the Company, and undoubtedly, it has priority.

Alpiq Csepeli Szolgáltató Kft. is the operation and maintenance company of Csepel II Power Station, and it also performs other tasks associated with running the business. Electricity generation, heat and hot water production are the main activities of Csepel II Power Plant.

Sustainable energy, climate change and biodiversity are core topics when it comes to Alpiq's activity.

We commit to increase our renewable energy production and to lower our overall shares in greenhouse gas (GHG) emitting technologies. We also work on optimizing our energy consumption and activities in order to lower our direct CO₂ emissions.

Alpiq Csepeli Szolgáltató Kft. recognizes the interaction between its activities at Csepel II Power Plant and the environment, and therefore, we do everything in our control to prevent environmental pollution and ensure a continued development.

We aim at maintaining a high-standard environmental policy, preventing air and water pollution, and continually improving our environmental performance.

As part of this objective, we aim at operating and maintaining the Plant in a manner such as to prevent any adverse impact on the environment.

These aims are achieved by:

- Maintaining an effective environmental protection system.
- Handling raw materials and wastes safely.
- Promoting the efficient use of energy and material resources, and by recycling and reuse where possible.
- During our activities and decision-making, considering and controlling the impact on the environment
- Reporting immediately the events that have an adverse impact on the environment and responding promptly and effectively to any environmental incident.
- Striving for developing and maintaining good relations with the authorities.
- Operating management systems that help reduce the environmental burden created by plant operations and other activities.
- Educating and training employees to conduct their work activities in an environmentally responsible manner, as well.
- Ensuring that contractors on site work to the same environmental standards as adopted by ourselves.
- Promoting understanding and awareness of environmental issues amongst staff, suppliers, and contractors, and within the community.
- We encourage our employees to use public transportation when commuting as well as for professional travelling, while avoiding airborne transport whenever possible.
- Regularly monitoring and auditing processes and procedures to ensure that our activities truly comply with regulations. Appropriate actions are taken wherever necessary.
